1 Introduction

Eurex Group provides various trading and clearing services to its membership. Position management is provided as a part of the clearing services. This proposal is in the context of regulatory reporting of positions for EMIR. It adds the possibility to uniquely identify a position entity with a single numeric identifier that represents a shortcut to the collection of attributes related to instruments and accounts that are currently needed to describe a position entity.

The following extensions are proposed:

- New field PositionID(<u>180</u>2618) for position maintenance messages to report positions
- New valid value "PositionID" for RelatedPositionIDSource(1863)
- New valid values for PosTransType(709) to cover corporate actions, assignments, creation due to exercise, close-out and transfers

2 Business Requirements

The business requirement is to support the ability of a clearinghouse to assign a numeric identifier that uniquely identifies a position entity within a specific context, e.g. a clearing participant. This identifier can then be passed back to the owner of the position and can be used by the clearinghouse for regulatory reporting to populate the UTI (Unique Trade Identifier).

2.1 Entity Identifier for Positions

It is proposed to add a new field PositionID(HBD2618) to the root level of the following position maintenance messages.

- PositionReport
- PositionMaintenanceReport

2.2 Reference to a Position

It is proposed to extend the list of possible sources for RelatedPositionID(1862) by adding a new value "PositionID" to RelatedPositionIDSource(1863).

2.3 Additional Position Transaction Types

It is proposed to extend the list of possible values for PosTransType(709) to convey additional use cases for position related messages. The list includes transactions related to the transfer of positions. This is intended to support the new, dedicated messages for position transfers (for details see Extension Pack 189, <u>http://www.fixtradingcommunity.org/pg/extensions/extension-pack?ExtensionID=EP189</u>). The position report messages can be used to convey the results of a position transfer on a more granular level. The new transaction types related to position transfers are not to be used to request a transfer.

- Corporate Action
- Assignment of a position due to an exercise (Notification)
- New futures position due to the exercise of an options position (Position Creation)
- Close out of a position (Close Out)
- Reversal of a close out of a position (Reopen)
- Intra-firm position transfer (Internal)
- Inter-firm position transfer (External)
- Transfer of all positions to the clearinghouse or another firm (Transfer of Firm)

4 Proposed Message Flow

There are no changes to the workflow for position maintenance. However, it is proposed that the clearinghouse always provides full details of the position entity in addition to the PositionID(TBD2618) field due to the fact that this serves as reference data to establish a link between the numeric identifier and the instrument and account details that otherwise uniquely identify a position. It should not be limited to the workflow establishing a new position but be provided for update confirmations as well.
