### 4 Settlement Instruction Examples and Notes

Several examples are included below. Note that the mapping to SWIFT MT541/543 is included in parenthesis.

As indicated in the best practice, the minimum is to have brokers to provide 3 settlement parties (PSET, Agent/Clearing Broker, Settlement Broker). If need to provide 4 parties, the additional one will be RECU/DEC (784 SettlPartyRole = 28). The buy-side will validate the Broker's settlement instruction to make sure they provide us the SSI based on the security market practice group guideline (? reference). For example, if the market requires us to have the participant ID to settle, then the buy-side will reject the confirmation if the broker doesn't provide us the valid BDI.

#### Regarding SWIFT/FIX mapping

- The value in tag 784 specifies the Swift categorization as to which party is being represented.
- The value in tag 783 specifies the Swift categorization as to how that party is being represented. Only when this is value H (centralized identifier, containing DSS) does this have any special impact onto the Swift categorization.
- The value in tag 782 specifies the party itself.

When there is an underlying tag 786, this clarifies further the party being represented. In such a case, tag 785 specifies the sub-party itself.
